TERMS AND CONDITIONS OF SALE LOUVINI

ORDER

Orders can be placed via the B2B website www.louvini-pro.com, by telephone or by e-mail to b2b@louvini.com. All bulk orders placed are subject to our terms and conditions of sale. Prices are subject to change without notice. The first order must be at least 800 euros excluding VAT and at least 250 euros excluding VAT for restocking orders with a delivery address in France. Outside France, the minimum order value must be 1,600 euros excluding VAT and 500 euros excluding VAT for restocking orders. The delivery time and the price of transport will be calculated at the time the order is placed. Prices are exclusive of VAT and are subject to the applicable value added tax (hereinafter «VAT»). Buyers must provide a valid business tax number, as well as their billing, shipping and contact information. Estimated shipping dates are provided to the buyer at the time of order confirmation and shipping costs will be added to the final invoice.

PAYMENT

Prepayment, including shipping charges, is required to complete the order. We accept payment by bank transfer or credit card only.

DELIVERY

All orders are shipped from Paris, France. The buyer will receive the tracking number by email upon shipment. International customers are responsible for any additional import fees, tariffs or taxes.

REFUNDS

Buyers must notify us of any defects, damages, shortages or other problems within 7 days of receipt of the goods. Please contact b2b@louvini.com to initiate a replacement or refund/credit note.

TERMS AND CONDITIONS OF SALE LOUVINI PROFESSIONALS

The purpose of the present general conditions of sale (hereinafter "GTC") is, on the one hand, to inform any Distributor who fulfils the conditions set out in Article 1 (hereinafter the "Distributor") of the terms and conditions under which LOUVINI proceeds with the sale and delivery of the Products ordered and, on the other hand, to define the rights and obligations of the Distributor and LOUVINI within the framework of the sale of Products of the LOUVINI brand.

1. SCOPE

The General Terms and Conditions apply, without restriction or reservation, to all sales concluded between, on the one hand, LOUVINI, a French one-person simplified joint stock company with capital of €1,000, registered with the Nanterre Trade and Companies Register under number 850 834 235, publisher of the www.louvini-pro.com, whose registered office is located at 39 Avenue Henri Bergson, 92380 Garches (France), identified with the intracommunity VAT number FR00850834235 (hereinafter referred to as "LOUVINI"), and, on the other hand, the Distributor wishing to acquire the products offered for sale by LOUVINI (hereinafter referred to as the "Products") either by taking an order by telephone, by e-mail or by any means subject to LOUVINI's validation of the order. For the application of the present, it is agreed that the Distributor and LOUVINI will be collectively referred to as the "Parties" and individually referred to as the "Party".

The GTC apply exclusively to Distributors:

- Who retail the Products to end consumers.

And who meet the conditions set forth in this article.

For the purposes of the GTC, a Distributor is a professional who meets the following conditions:

- Conditions relating to the Distributor's points of sale: each Distributor's point of sale must (i) have staff qualified for sales, and in sufficient numbers, and with knowledge of LOUVINI Products, and (ii) meet a sufficiently high standard of image and quality, in keeping with LOUVINI's premium image.
- Sales through the Distributor's internet sites: the Distributor who wishes to sell LOUVINI Products on his own internet site, using the name or image of the LOUVINI brand, must first request LOUVINI's written agreement. The Distributor's Internet site must be exclusively related to the activity of the Distributor's point of sale, of which it is an accessory. The Distributor's Internet site must only sell Products which are also offered for sale in the Distributor's point of sale in compliance with the qualitative conditions described above.

Subject to compliance with these conditions, the fact that the Distributor orders the Products implies full and complete express acceptance of the GTC, which the Distributor acknowledges having read prior to his order. The Distributor, prior to his order, declares that the purchase of Products from LOUVINI corresponds to his professional activity and that it is made for the purpose of resale at retail and to end consumers, customers of his point of sale in compliance with the conditions. Any order which does not meet the criteria set out in the GTC will be considered - by LOUVINI - as null and void. To ensure the coherence of the LOUVINI distribution network, and in the interest of all the Distributors distributing the Products, it is fundamental that LOUVINI be put in a position to verify that its Products are sold by Distributors who respect the image of the brand and the GTC. This is why any opening of a new point of sale requires prior information from the Distributor to LOUVINI. These GTC shall prevail over any other general or special conditions not expressly approved by LOUVINI.

2. PRICES

The prices applicable to the Products at the date of the GTC are shown in the area dedicated to professionals. The sales prices of the Products, indicated in euros, are those in force on January 1st of the current year. LOUVINI may modify prices during the year as of right. These prices and delivery are EX-Works (Incoterms 2020).

Delivery is free of charge for all deliveries in Metropolitan France, Corsica, and Monaco (except for additional transport costs required by the shipment) and the order must be for a minimum of 800 euros excluding VAT for the first order and 250 euros excluding VAT for restocking orders for Distributors in France. Outside France, orders must be for a minimum of 1,600 euros excluding VAT and 500 euros excluding VAT for restocking orders. Delivery time and shipping costs will be calculated at the time of order. Prices are exclusive of VAT and are subject to the value-added tax (hereinafter "VAT") applicable on the day of the order. Any change in the applicable VAT rate will automatically be reflected in the price of the Products. For deliveries outside the European Union (including Switzerland), VAT exemption is applied in accordance with article 262-I-1 of the French General Tax Code. For deliveries in France exempt from VAT, the VAT exemption is applied in accordance with article 275 of the French General Tax Code. For intra-Community deliveries exempt from VAT, the VAT exemption is applied in accordance with article 265-ter-1 of the French General Tax Code.

Customs fees and procedures related to the export of Products remain the responsibility of the Distributor.

The Distributor acknowledges that the customs charges are his responsibility. In the absence of payment of these customs charges or of recovery of the Products and return of the Products at LOUVINI's expense, LOUVINI may obtain reimbursement of these customs charges from the Distributor. In application of the principle of price freedom, the Distributor remains free to determine its prices, in application of the provisions of article L.442-2 of the French Commercial Code, which prohibits the Distributor from reselling the Products at a price lower than its effective purchase price (including costs and taxes of any kind), within the meaning of the provisions of said article. In addition, to preserve the brand image of LOUVINI brand Products and to maintain consistency in its distribution network, LOUVINI provides its Distributors with a list of recommended selling prices.

3. OBLIGATIONS OF THE DISTRIBUTOR

When marketing Products, the Distributor undertakes to:

- Have a sufficient stock of each referenced Product and display them visibly and harmoniously, sheltered from heat, presentation labels on the front, in its shelf space and maintain all referenced Products on the shelf.
- Maintain Products in good condition, clean and dust-free, and remove deteriorated, soiled, opened or out-of-date Products from shelves.

4. ORDERS

The Distributor may obtain information on the Products offered for sale on the information sheets for each Product appearing on the LOUVINI Internet site or communicated by LOUVINI. The Distributor may request Products by any means (e-mail, telephone, etc.). From the moment the Distributor has validated his order, he is deemed to have accepted with full knowledge of the facts and without reservation the present GTC, the prices, volumes and quantities of products offered for sale and ordered. The sale will only be considered final after LOUVINI has sent the Distributor confirmation of acceptance of the order (with a summary) by e-mail, and after LOUVINI has received payment in full. LOUVINI may modify at any time the assortment of Products offered for sale, according to constraints linked to its suppliers. It may freely delete, add, or modify Products in relation to the range of Products existing at the date of the GTC.

LOUVINI will inform the Distributor as soon as possible of any modification concerning the conditions of location or restocking. Information on the availability of Products is provided to the Distributor at the time the order is placed. As this information comes directly from suppliers, errors or modifications may exceptionally occur. In any event, and in the event of unavailability of one or more Products after an order has been placed:

- The Distributor will be informed as soon as possible.
- The order for the Product(s) concerned will be postponed and processed as soon as possible.
- If the order has already been paid for by the Distributor, in whole or in part, LOUVINI will issue a credit note for the sums paid and corresponding to the unavailable products.

5. MODALITY OF PAYMENT

The price is payable in full at the time of order. All orders are payable in euros, all taxes and compulsory contributions included. Any bank charges remain the responsibility of the Distributor (including in the case of a refund). Upon express request, and subject to acceptance by LOUVINI, certain Distributors may benefit from payment terms. Penalties of an amount equal to three times the legal interest rate will be applied automatically to unpaid amounts from the invoice due date or in the event of bank payment rejection. In addition, the Distributor will automatically be liable for a flat-rate indemnity of 40 euros for collection costs. Should LOUVINI's actual collection costs exceed this amount, LOUVINI reserves the right to request additional compensation upon justification. Penalties are payable without the need for a reminder. They run automatically from the day following the payment date shown on the invoice.

To pay for his order, the Distributor may use the following means of payment:

- By credit card, made directly online via secure transaction,
- By bank transfer.

Purchase invoices are sent by e-mail to the e-mail address indicated by the Distributor or by post at the Distributor's request.

6. DELIVERY

6.1. General rules

The Products ordered by the Distributor in accordance with the GTC will be delivered to the address indicated by the Distributor as the delivery address on the order concerned. LOUVINI is responsible for the choice of the carrier, as well as for the organization of delivery to the place indicated by the Distributor and within the deadlines referred to in article 2 when the Products are available.

6.2. Delivery modality

Under no circumstances may the Distributor refuse or not collect a delivery to cancel a definitive order. No reimbursement, in any form whatsoever, will be made in the event of refusal or failure to collect a delivery.

6.3. Non-conformity upon delivery (anomaly, damage, damaged parcel)

6.3.1. General rules

The Distributor is invited to check the apparent condition of the package and Products upon delivery. Goods travel at the recipient's risk. In the event of any anomaly concerning the parcel (damaged parcel, open parcel, trace of substances, etc.) or the Products ordered, or in the event of missing or damaged Products, the Distributor must follow the procedure described below corresponding to the conditions of the order.

Non-compliance with the appropriate procedure excludes any recourse against the carrier and LOUVINI and the Distributor may not claim any reimbursement. The Distributor may also not claim that LOUVINI should proceed with a new delivery of the Products ordered. The Distributor should contact LOUVINI to find out how to return damaged Products. The procedure for returning damaged Products indicated by LOUVINI must be followed by the Distributor. Failing this, the Distributor will not be entitled to any reimbursement or exchange of the Products in question.

6.3.2. Procedures to be followed when the package is damaged.

In the event of damage, shortage or delay, the Distributor must express his reservations on the delivery note presented by the carrier, then confirm his reservations by registered letter to the carrier within three (3) days of the delivery date, in the form and within the time limits prescribed by article L133-3 of the French Commercial Code. A photocopy of the delivery note, and the carrier's receipt must be enclosed. These reservations must enable precise identification of the incident and the Product (date, marking). No logistical penalties or product returns for non-conformity will be accepted unless these conditions are met.

In the absence of reservations clearly and precisely mentioned on the transport documents and confirmed to LOUVINI and the carrier within three (3) working days following delivery by registered letter accompanied by supporting documents, the Products will be deemed to conform to the order and LOUVINI's liability cannot be called into question for non-conformity of the delivery.

6.3.3. Procedure to be followed in the event of a missing or damaged Product.

The Distributor must report the absence or deterioration of the Product to LOUVINI. To be considered by LOUVINI, all requests must be sent by registered letter within three (3) days of receipt of the Products by the Distributor and must be accompanied by photographs enabling the reality of the requests to be ascertained.

7. RETENTION OF TITLE AND TRANSFER OF RISK

LOUVINI reserves, until full payment of the price by the Distributor, a right of ownership on the Products, allowing it to repossess said Products. Any deposit paid by the Distributor will remain the property of LOUVINI by way of lump-sum compensation, without prejudice to any other action it may be entitled to take against the Distributor as a result. Consequently, LOUVINI may avail itself of this right as soon as the payment deadline has not been respected to reclaim the Products delivered. The Distributor recognizes this right and will have no choice but to return LOUVINI's Products on first request. On the other hand, the risk of loss and deterioration will be transferred to the Distributor as soon as the Products are handed over to the carrier.

8. LIABILITY

The Products comply with the requirements of current French law relating to personal health and safety, fair trading, and consumer protection at the time they are placed on the market. For orders outside Metropolitan France, it is the responsibility of the Distributor to obtain information from the local authorities in his country concerning any restrictions on the import and use of the Products ordered. LOUVINI may not be held responsible for the purchase of a Product considered to be non-compliant in each country, even though this Product complies with French regulations. In this respect, LOUVINI cannot guarantee that the information on the packaging of the Products is translated into all the languages of the countries of delivery.

The liability of LOUVINI under the obligations of the GTC shall not be incurred in the event that the non-performance of its obligations is attributable to the act of a third party even if foreseeable, to the fault of the Distributor, or to the occurrence of an event of force majeure as defined by the Civil Code or to any other event which was not reasonably under the exclusive control of LOUVINI. LOUVINI may not be held liable for any damage caused to the Distributor or to a third party resulting from improper use of the Products sold by LOUVINI. Any claim lodged by an end consumer with the Distributor against LOUVINI must be notified by the Distributor within seven (7) days of the occurrence of the event which is the subject of the claim. In any event, LOUVINI's liability to the Distributor shall not exceed the amount of orders placed by the Distributor during the year in question.

9. INTELLECTUAL PROPERTY

The LOUVINI trademark, as well as all the figurative or nonfigurative trademarks, illustrations, images and logos and all content appearing on all media and in particular on the Products are and remain the exclusive property of LOUVINI and/or its partners and suppliers and are protected under the provisions of the French Intellectual Property Code. Any total or partial reproduction, modification or use of these trademarks, illustrations, images, and logos, for any reason and on any medium whatsoever, without the prior written consent of LOUVINI is strictly forbidden. The Distributor also refrains from altering, in any way whatsoever, the Products or elements relating thereto which would modify or be likely to modify their content and/or appearance. Violation of the obligations referred to in the present article constitutes an infringement within the meaning of the French Intellectual Property Code and subjects any offender to the criminal and civil penalties provided for in this respect by law. Furthermore, in the event of damage to the image of LOUVINI, the LOUVINI brand or the Products, LOUVINI reserves the right to suspend or cancel any execution of an order and/or delivery, whatever its nature and level of execution.

10. CONFIDENTIALITY

The commercial documents drawn up by LOUVINI, including the GTC, are communicated to the Distributor for the sole purpose of negotiating, formalizing, and executing the commercial relations between the Parties. This information, and in particular the tariffs, tariff advantages proposed by LOUVINI and, where applicable, the business plan negotiated and agreed between the Parties, constitute strategic information which is confidential. Consequently, the Distributor undertakes to keep confidential all information, of whatever nature, as well as commercial details, techniques, scientific work, and formulations to which he may have access, and to maintain the confidentiality of all information which may be accessible to him on his relations with LOUVINI. These obligations remain in force if the information has not fallen into the public domain. The Distributor acknowledges that failure to comply with this undertaking may result in the payment of damages.

11. PERSONAL DATA

In the context of the performance of the GTC, the Parties may provide each other with personal data relating to their personnel (in particular, their name, title, signature, and e-mail address). In accordance with regulations governing personal data, the Parties undertake not to use such data for any purpose other than that necessary for the performance of the present agreement. The Parties also undertake to keep the data for no longer than is necessary for the purposes for which it is processed. The processing conducted by LOUVINI is conducted under the conditions set out in the Privacy Policy, which each new Distributor is invited to consult when creating their account.

In addition, specific information appears on each collection form to ensure that Distributors are fully informed before their data is processed. Persons whose data is processed have a number of rights, in particular the right to access and rectify their data. They may exercise their rights by contacting:

12. FORCE MAJEURE

Any circumstances beyond the control of the Parties preventing the performance of their obligations under normal conditions shall be considered as grounds for exoneration from the Parties' obligations and shall result in their suspension. The Party invoking the circumstances referred to above must immediately notify the other Party of their occurrence, as well as of their disappearance. Force majeure shall mean any irresistible event or circumstance, external to the Parties, unforeseeable, unavoidable, beyond the control of the Parties and which cannot be prevented by the latter, despite all reasonably possible efforts. The following are expressly considered as cases of force majeure or fortuitous events, in addition to those usually accepted by the jurisprudence of French courts and tribunals: blockage of means of transport or supplies, earthquakes, fire, storms, floods, lightning, stoppage of telecommunications networks or difficulties specific to telecommunications networks external to the Distributors. The Parties will meet to examine the impact of the event and agree on the conditions under which performance of the contract will continue. If the case of force majeure lasts for more than three (3) months, the present GTC may be terminated by the aggrieved Party.

13. APPLICABLE LAW AND JURISDICTION

The language of these GTC is French and they are subject to French law. In the event of a dispute, the Paris Commercial Court shall have sole jurisdiction.
